PURPOSE OF SCHOLARSHIP AWARDS PROGRAM

For the 2018-2019 Animal Scholarship Program, the Hudson Folkerts Memorial Foundation will award animal project scholarships to current Tomball FFA or Tomball Memorial FFA students who are financially unable to purchase and raise a supervised agricultural project for the 2018 Tomball ISD project show.

ELIGIBILITY

- Applicant must be a current Tomball High School or Tomball Memorial High School
- Applicant must have an overall 2.5 or greater grade point average from the previous
- school year. If the student's average is below 2.5, special consideration may be made on an individual basis.
- Applicant must submit a copy of his or her official school transcript, signed and sealed by the school registrar, with the HFMF Animal Scholarship Application.
- Applicant must be in good standing in both the school and community.

SELECTION PROCESS

All applications will be reviewed by members of the HFMF Animal Scholarship Committee. The evaluation will be divided into the following categories: Scholastic Achievement (Academic G.P.A.); FFA/4-H Leadership, Involvement and Activities; Other School Activities; Community Leadership and Activities; and Personal Essay. Part of the evaluation process will be feedback from Tomball ISD faculty including Agricultural teachers, counselors, etc. Applicant must be in good standing within the school and the community.

Important: The deadline for submitting a printed application to an FFA Instructor at Tomball High or Tomball Memorial High is March 1, 2018. **Absolutely no late applications will be accepted.**

Applicants will be notified by either his or her respective Ag teacher or by an HFMF Committee Member regarding his or her application's acceptance or denial.

SCHOLARSHIP AMOUNT AND METHOD OF PAYMENT

The Foundation will pay directly to Tomball ISD for the animal accepted by HFMF for the student at the mandatory FFA meeting. The student and a parent will be required to attend the meeting and pay the \$20 FFA dues to their respective chapter. If the student wishes to keep the project at the TISD Project Facility, the Foundation will pay the rental fee directly to Tomball ISD. A feed account funded by HFMF in the student's name will be set up at D&D Feed Supply solely for the purchase of purchasing feed for the animal. The student will be required to keep accurate records on AET and provide HFMF with monthly progress reports. HFMF reserves the right to reclaim the animal if at any time it is not being taken care of properly by the student. HFMF is not responsible for sickness, injury, or death of the animal.

SELECTION PROCESS

1. To ensure that future students are able to have the experience of raising an FFA supervised animal funded by HFMF, any proceeds derived from the sale of the student's animal will first be used to repay the costs of purchasing, accommodating and feeding during the course of raising the animal. Following that, any remaining proceeds will be distributed to the student. Any add-ons will be directly given to the student, net of the Tomball FFA deduction.
2. Each student will be required to seek buyers for his or her animal sold at the show in case the animal does not make the auction.
3. Students who become ineligible to show due to grades or behavior will immediately turn ownership of the animal back to HFMF.

PIG - \$1,200

LAMB - \$700

GOAT - \$700

TURKEYS - \$400

CHICKENS - \$250

RABBITS - \$250

Please note that any extenuating health issues that arise with your project animal will be considered after discussion with your FFA advisor. The dollar amounts indicated above factor in a limited amount of veterinarian costs.

All approved applicants & guardians will need to meet with an HFMF representative to discuss budgeting and reporting processes that are required as an Animal Scholarship Recipient.
